

Informed Consent, Release of Liability, and Assignment

With respect to my participation in The Color Run ("Event") being sponsored by Halliburton Energy Services, Inc. and the Halliburton Charitable Foundation (collectively "Halliburton") I understand that there may be health and/or injury risks associated with participation in activities requiring physical exertion, including but not limited to transient dizziness, fainting, nausea, muscle cramping, musculoskeletal injury, sprains and strains, heart attack, stroke or death. In addition, I understand and consent to colored powder that contains cornstarch ("Colored Powder") being thrown on me or in my vicinity during the Color Run. I also understand that there is a possibility that the Colored Powder could cause staining of my person, of clothes, shoes, and any other materials the Colored Powder may come in contact with during the Event.

I certify that I am capable of performing physical exercise and acknowledge that I am voluntarily participating in the activities associated with the Event, and acknowledge and agree to assume all risk associated with such activities with knowledge of the dangers involved. I understand that I am participating with full knowledge of my personal limitations and will be fully responsible for complying with any restrictions prescribed for me by my personal physician. I will consult with my physician prior to my commencing any activities associated with the Event. I further understand and acknowledge that neither Halliburton, its parent, subsidiary or affiliated entities nor any of their respective officers, directors, employees, agents, contractors or subcontractors, or staff ("Halliburton Personnel") will be monitoring my individual condition in connection with participation in any activities associated with the Event. I understand that the Halliburton Personnel staff are not medical professionals and have not received training in medical or physical activity assessment.

If I experience dizziness, fainting, nausea, muscle cramping or any other symptoms while participating in any activities associated with the Event, I will discontinue the activity and consult my physician.

In consideration for being allowed to participate in the Event and any activities associated therewith, I hereby agree to assume all risk of participation in such activities, and further agree to hold harmless Halliburton, all Halliburton Personnel and, other participants from any and all claims, suits, losses, or related causes of action for damages, including but not limited to, such claims, that may result from any property damage, injury or death, accidental or otherwise, during, or arising in any way from my participation in the Event.

I expressly agree that neither Halliburton nor any Halliburton Personnel shall be liable for any damages arising from personal injuries or property damage sustained by me in connection with my participation in the Event.

BY EXECUTING THIS AGREEMENT, I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY INJURIES OR DAMAGES THAT MAY OCCUR TO ME OR MY PROPERTY IN CONNECTION WITH MY PARTICIPATION IN THE EVENT AND FURTHER AGREE THAT NEITHER HALLIBURTON NOR ANY HALLIBURTON PERSONNEL, AS DEFINED HEREIN, SHALL BE LIABLE FOR ANY DAMAGE, LOSS OR THEFT OF PERSONAL PROPERTY. IN ASSUMING FULL RESPONSIBILITY FOR THE RISK OF INJURIES, DAMAGES, OR LOSSES THAT MAY OCCUR TO ME IN CONNECTION WITH MY PARTICIPATION IN THE EVENT, I DO HEREBY FULLY AND FOREVER RELEASE AND DISCHARGE HALLIBURTON AND ANY AND ALL HALLIBURTON PERSONNEL, AS DEFINED HEREIN, FROM ANY AND ALL CLAIMS, DEMANDS, DAMAGES, RIGHTS OF ACTION, OR CAUSE OF ACTION, PRESENT OR FUTURE, WHETHER THE SAME BE KNOWN OR UNKNOWN, ANTICIPATED, OR UNANTICIPATED, RESULTING FROM OR ARISING OUT OF MY PARTICIPATION IN ANY ACTIVITIES ASSOCIATED WITH THE EVENT, INCLUDING BUT NOT LIMITED TO ANY CLAIM FOR NEGLIGENCE ALLEGED AGAINST HALLIBURTON OR ANY HALLIBURTON PERSONNEL, AS DEFINED HEREIN.

I further hereby knowingly and voluntarily authorize and assign to Halliburton, and any of its parent, subsidiary, and affiliated entities the full and unencumbered right to create, maintain, and edit any and all photographs, audio, video, electronic media or other recordings of any kind whatsoever ("Recordings") taken of me in connection with my participation in the Event, and further knowingly and voluntarily authorize Halliburton and any of its parent, subsidiary, and affiliated entities the unrestricted rights to use, reproduce, post, and disseminate any Recording referred to herein for any reasonable purpose, including, but not limited to press releases, marketing materials, presentations, or website testimonials, without requirement for further acknowledgment or remuneration or compensation of any kind. I hereby release Halliburton and any of its parent, subsidiary, and affiliated entities from any and all liability, costs, or damages resulting from the creation or use of the Recordings described herein.

This informed Consent, Release of Liability and Assignment shall be binding upon my heirs, spouse, or other next of kin, executor, administrators and assigns.
